Indiana Licensing Requirements

Cosmetology : *Each student must complete the following:*

- Complete 1500 clock hours of training.
- Complete the State practical book requirements.
- Satisfactorily pass all written tests with a 75% or higher.
- Pass all practical exams with a 75% or higher.
- Pass the school final written exam with a 75% or higher.
- Satisfy all financial responsibilities to the school.
